What is this type of insurance?

This product is designed for those seeking financial protection against the cost of repairing or replacing their glasses following damage, loss or theft.



What is insured?

- ✓ This policy covers the cost of replacing your glasses, or the insured components of your glasses, as a result of accidental damage or wear and tear not covered by any manufacturer, warranty, guarantee, or existing insurance during the period of cover.
- ✓ The insured components of your glasses are those parts purchased at Vision Express.
- ✓ Replacement of insured components includes fitting and installation services.
- ✓ Loss or theft of your glasses is also covered.
- ✓ Where a replacement is required, components will be replaced with new parts of the same type and quality.
- ✓ Cover is provided up to the sum insured, less your excess.



What is not insured?

- ✗ Deliberate or intentional damage.
- ✗ Repairs or replacements carried out by persons not authorised by Vision Express.
- ✗ Frames or lenses not purchased from Vision Express.
- ✗ The cost of replacing lenses where a new prescription is required.

For glasses with electronic components:

- ✗ Indirect losses or damages of any kind, including those arising as a result of a cyber incident.
- ✗ Any other electronic damage to the product, such as signal interference or voltage fluctuations.



Are there any restrictions on cover?

- ! The customer will pay an excess of 25% of the replacement cost of the glasses (50% in the event of loss or theft).
- ! Any costs incurred as a result of being unable to use your glasses, or any costs other than the direct cost of replacing the insured components of your glasses.
- ! Any damage that is covered by the manufacturer's guarantee or by Vision Express



Where am I covered?

- ✓ The insurance cover applies worldwide, but claims must be made in the country of purchase.



What are my obligations?

- In the event of a claim you must inform Vision Express as soon as possible.



When and how do I pay?

The premium is due at the point of purchase of your glasses and insurance contract, and may be paid by cash or any other accepted payment method.



When does the cover start and end?

Cover begins on the date of purchase of your glasses. The contract runs for two years for prescription glasses or sunglasses (excluding those with Stellest lenses), and one year for non-prescription glasses, sunglasses, or glasses with Stellest lenses. Cover will not end in the event of a claim. If your glasses are replaced, cover will transfer to the replacement glasses for the remainder of the original term.



How do I cancel the contract?

You may cancel your insurance contract within 100 days of purchasing your glasses. Outside of this period, there is no right to cancel. To cancel, please contact a Vision Express store or our customer service team within 100 days of purchase, by email, telephone, or in person.

Grand Advantage Glasses Policy Document

This is your Grand Advantage policy document (the "Policy") which covers your frames/and or lenses (herein referred to as glasses) (as shown on the VE receipt with the policy number for this Policy) purchased through either

- ❖ Vision Express (UK) Limited or
- ❖ Vision Express Ireland Limited

(together "VE").

This Policy is underwritten by

- ❖ Great Lakes Insurance UK Limited* ("Great Lakes") for policyholders resident in **the United Kingdom or Jersey** and by
- ❖ ERGO Direkt Versicherung AG ("ERGO Direkt") for policyholders resident in **Ireland**

(together the "risk carriers").

*Great Lakes Insurance UK Limited is an insurance company with registered offices at 1 Fen Court, London EC3M 5BN. Great Lakes Insurance UK Limited is authorised by the Prudential Regulation Authority and regulated by the Financial Conduct Authority and Prudential Regulation Authority. Details of its authorisation can be found on the Financial Conduct Authority's website.

ERGO Direkt Versicherung AG is a German insurance company with its headquarters at Karl-Martell-Strasse 60, D-90344 Nuremberg, Germany. ERGO Direkt Versicherung AG is authorised by BaFin in Germany and regulated by the Central Bank of Ireland for conduct of business rules. Details about the extent of our regulation by the Central Bank of Ireland are available from ERGO Direkt on request.

Details about the risk carriers are set out below at the end of this Policy.

The risk carriers will provide protection cover (subject to the below terms and conditions) for the periods stated below:

Product Type	Period of Cover
Prescription/corrective glasses, prescription/corrective sunglasses, or glasses with electronic components (excluding pairs with Stellest Lenses).	24 months from the date of purchase
Non-prescription glasses, or sunglasses or those with Stellest Lenses or glasses with electronic components.	12 months from the date of purchase

The periods of 24 and 12 months are referred to respectively as the "period of cover", as applicable in the context for which they are used.

Your contract of insurance is set out in this Policy document. Your VE receipt provides evidence of your cover.

Please keep this Policy document and your VE receipt in a safe place as these will be required if you need to make a claim or want to cancel this Policy.

1. What is covered under this Policy

1.1 This Policy covers the costs for replacement of your glasses, or the insured parts of your glasses (the parts of your glasses purchased at Vision Express) as a result of

- accidental damage or wear and tear that is not covered by any manufacturer warranty, any other guarantee or insurance during the period of cover.
- or loss (e.g. due to theft or robbery,

up to the retail price before any discounts including any Value Added Tax (the "**Insured Sum**").

1.2 Replacement of insured parts of your glasses includes fitting or installation services. For glasses with electronic components, the charging pad will only be replaced on total loss of the glasses.

2. What is not covered under this Policy

2.1 This Policy will not cover costs for replacement of your glasses or insured parts of your glasses for:

- work which relates to a manufacturing defect or the recall of the glasses by the manufacturer or supplier.
- replacements carried out by persons not authorized by VE.
- damage caused by deliberate damage to, or neglect of, your glasses or not taking reasonable precautions to prevent any damage to your glasses.
- the replacement of lenses due to a change in your prescription.
- any costs suffered by you as a result of not being able to use your glasses, or any costs other than cost for replacement of insured parts of your glasses.
- frames or lenses not bought from Vision Express.

2.2 These exclusions apply to glasses with electronic components:

- indirect damages of any kind, for example as a result of a cyber incident. This includes the loss, damage, destruction, distortion, erasure, corruption or alteration of electronic data from any computer virus or similar mechanism, or as a result of any failure of the Internet.
- viruses, Malware or any other kind of data loss (only by products with electronics).
- any other electronic damage to the product (only by products with electronics).
- signal interference with the receiver or voltage fluctuations (only by products with electronics).

3. General conditions and limitations

3.1 In the event of a claim where your glasses have not been lost or stolen but need to be replaced entirely (total economic loss) you will receive a replacement set of glasses of the same type and quality up to the Insured Sum.

In the event of a claim where only an insured part needs to be replaced, we will replace this part.

An excess is a pre-agreed sum of money you need to pay to your insurance provider if you ever make a claim. If you make a claim, an excess will be applied as follows:

	Excess applied
If you receive a replacement set of glasses	25% of the Insured Sum (the value of the product insured under this policy)
If we replace the damaged part	25% of the value of the insured part, not exceeding a maximum of 25% of the Insured Sum
In the event of loss or theft you will receive a replacement set of glasses of the same type and quality up to the Insured Sum	50% of the Insured Sum.

In case of loss or theft of the insured glasses any eventual cost of the new glasses is calculated as follows:

If the list price of the new glasses is equal to or exceeds the list price of the insured glasses, the value of the replacement glasses will be a maximum of the list price of the original insured glasses, less your excess of 50% of the insured sum.

If the list price for the new glasses is lower than the list price of the insured glasses, your excess is 50% of the actual list price for the new glasses and no further payments are necessary.

3.2 If your glasses or the insured parts of your glasses prove to be not possible to replace, or an identical set of glasses is not available at VE's stores, VE will replace them with an equivalent product subject to you paying the Excess set out at Section 3.1 above.

3.3 If you choose to upgrade your glasses, the difference between the Insured Sum and the retail price before any discounts of the new pair must be paid by you in full together with any applicable Excess.
3.4 If VE replace your glasses following a claim made by you, the cover provided by this Policy will continue in respect of the replaced glasses for the remainder of the period of cover and subject to the terms and conditions of this Policy.
3.5 This Policy must be applied for prior to the purchase of your glasses, either when you order your glasses or when you make payment or when you take possession of your glasses.
3.6 If you receive replacement glasses because it is considered uneconomical or not possible to replace parts, then VE may, take possession of your original glasses provided they have not been lost or stolen
3.7 It is a condition precedent of this Policy that you must take all reasonable precautions to prevent any damage to your glasses.
3.8 This Policy cannot be transferred to any other person or persons.
3.9 If you purchased your glasses through VE in the UK or Jersey this Policy shall be governed by English Law and shall be subject to the exclusive jurisdiction of the English Courts. If you purchased your glasses from VE in Ireland this Policy shall be governed by the Laws of Ireland and shall be subject to the exclusive jurisdiction of the Irish courts.
3.10 This Policy shall not give any person who is not a party to it any right to enforce any of its provisions.
3.11 The risk carriers may vary the terms and conditions of this Policy, at any time in the risk carriers' sole discretion, in the event that it is considered necessary or if there is an event outside the control of the risk carriers which may have an impact on future claims and which could not have been reasonably foreseen when the risk carriers last reviewed the cover terms and premiums or in the event of any change in law or regulation or a decision of the Financial Ombudsman Service or the Financial Services and Pensions Ombudsman affecting this Grand Advantage Policy, for example a change in Insurance Premium Tax or other tax. Before the risk carriers make any proposed change, the risk carriers will give 30 days' notice in writing to you at the address you provided when purchasing this Policy. Any changes shall take effect once you have provided written confirmation of your acceptance. If you do not accept the proposed changes, you may cancel this Policy by providing notice to the relevant risk carrier using the contact details provided below. In the event of cancellation any premium you have paid and unused at the date of cancellation shall be returned to you.
3.12 In Ireland, all monies which may become payable by ERGO Direkt under this Policy shall in accordance with Section 93 of the Insurance Act 1936 be payable and paid in the Republic of Ireland.
3.13 In Ireland, the appropriate Stamp Duty has been or will be paid in accordance with Section 5 of the Stamp Duties Consolidation Act, 1999 (as amended).
3.14 In Ireland, all monies which may become payable by ERGO Direkt under this Policy will be paid in Euros.
3.15 Embargo Provision
3.15.1 In the United Kingdom or Jersey we will not provide any benefit under this contract of insurance if doing so would expose us to any sanction, prohibition or restriction under any United Nations resolutions, or the trade or economic sanctions, laws or regulations of the European Union, United Kingdom, United States of America or any other jurisdiction whose laws we are legally obligated to comply with.

3.15.2 In Ireland, irrespective of the other contractual provisions, insurance cover only exists if and for as long as there are no economic, trade or financial sanctions or embargoes of the European Union or the Federal Republic of Germany that are directly applicable to the contracting parties. This also applies to economic, trade or financial sanctions or embargoes by the United States of America, insofar as this does not conflict with the legal provisions of the European Union or the Federal Republic of Germany.

4. Cancellation

4.1 You have the right to cancel this Policy within 100 days of purchasing your glasses and will receive a full refund of any premium you have paid, provided you have not made a claim under this Policy. Where the premium for this Policy has been paid by VE no premium or other monies will be refunded to you in connection to this policy.

4.2 If you decide to cancel your Policy you must contact a VE Store, or our customer service team, within 100 days of purchase of your glasses by e-mail, telephone or in person.

5. How to make a claim

If during the period of cover your glasses develop a fault due to normal wear and tear or accidental damage, you should return your glasses to your nearest store with any damaged parts.

If you purchased your glasses through **VE UK** you must report your claim to a VE store in the UK.

If you purchased your glasses through **VE Jersey** you must report your claim to the VE store **in Jersey**.

If you have purchased your glasses either through **VE UK** or **VE Jersey** and where a claim concerns theft of your glasses, you must file a report to the nearest police station and provide VE with a copy of the report.

In the event of loss of your glasses you must report this loss via an online lost property reporting service <https://www.reportmyloss.com/uk/> and provide VE with a copy of the report.

If you purchased your glasses through **VE Ireland** you must report your claim to a VE store **in Ireland**. In the event of loss or theft of your glasses you must report this to the Gardaí, within 24 hours of discovery, and provide VE with a copy of the report.

VE will then arrange for the insured parts of your glasses to be replaced or provide you with replacement glasses subject to the terms and conditions of this Policy.

6. Fraud

If you or anyone acting on your behalf makes any false or fraudulent claim or supports a claim knowing it to be false, fraudulent or misrepresentative, we may avoid this policy which would mean that the policy would cease and not cover any losses suffered.

7. Complaints

7.1 VE, Great Lakes and ERGO Direkt always aim to get it right, first time, every time. However, if you feel that you did not receive the level of service you would expect in relation to this Policy, in the first instance please contact us using the details below:

You have 6 months after you have been informed of the outcome of the complaint (or following the end of the 8-week period) to escalate your complaint to the Financial Ombudsman Service (**UK**), the Channel Islands Financial Ombudsman and/or the UK Financial Ombudsman Service (**Jersey**) or the Financial Services and Pensions Ombudsman (**Ireland**) (as applicable). Referral to an Ombudsman does not affect your rights to institute legal action.

8 Compensation Scheme

8.1 The risk carriers are regulated by the supervision of the Bundesanstalt für Finanzdienstleistungsaufsicht, Graurheindorfer Straße 108, D-53117 Bonn, Germany ("BaFin").

8.2 If you purchased your glasses through VE in the UK, Great Lakes is covered by the Financial Services Compensation Scheme (FSCS). If Great Lakes is unable to meet its liabilities, you may be entitled to compensation from the Scheme. This depends on the type of insurance cover you have and the circumstances of your claim.

However if you purchased your glasses through VE in Jersey, this Scheme does not apply.

If you purchased your glasses through VE in Ireland, ERGO Direkt is covered by the Insurance Compensation Fund. If ERGO Direkt is unable to meet its liabilities, you may be entitled to compensation from the Insurance Compensation Fund.
